All qualifying fish must be weighed in by 6:00 pm on the Harbor Scales in front of the Oceanside Harbor Office.  
The tournament channel will be VHF 65 If possible contact an OAC committee boat with boated legal fish.

**THE 100 LB MINIMUM WEIGHT IS IN EFFECT FOR THIS TOURNAMENT.  
FOR CONSERVATION PURPOSES, THERE IS A 1 FISH LIMIT PER BOAT IN EFFECT.  
IF MORE THAN 1 FISH ARE BOATED, THE BOAT WILL BE DISQUALIFIED.**

(There will be no junior category due to a 1 fish limit)

Awards for First, Second and Third places will be determined by the amount of  
participation in the tournament plus **\$ 250.00** from the OAC treasury.

*THE START OF THE TOURNAMENT WILL BE HELD UP UNTIL APPROXIMATELY 7:30 AM IF A RED FLAG IS FLYING TO  
ALLOW THE HARBOR PATROL TO DETERMINE CONDITIONS.*
